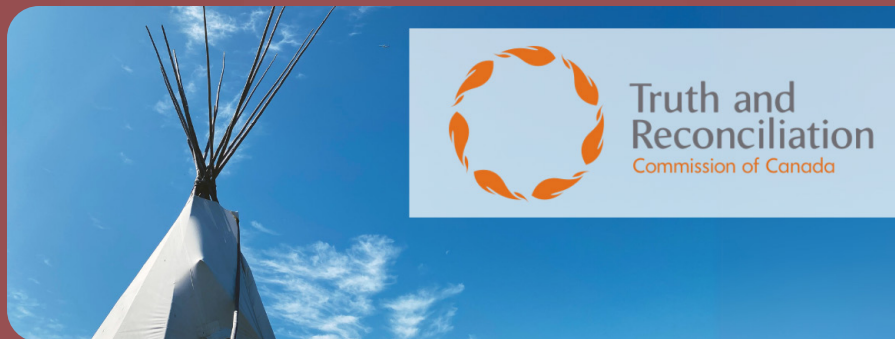

I am brand new to the role of President of the Law Society of Manitoba, serving less than a month at the time of the publication of this issue of Communiqué. As many of you know, I have taken office a year early. Merci et félicitations, Monsieur le juge Monnin.

While I cannot predict what will happen during my term, I can only say that I hope my presidency is a bit less eventful than Gerri Wiebe's turned out to be!

We are living in unprecedented times, and I anticipate that we, as a profession, and the Law Society, as the independent regulator of our profession in Manitoba, will be dealing with some significant issues this coming year.

The Law Society's role is to protect the public by regulating the delivery of legal services by a competent, ethical, and independent legal profession, and by advancing access to justice. The independence of the legal profession, and the independence of the judiciary, are fundamental to the rule of law and to democracy. As a profession, we may tend to take this for granted, or perhaps do not give it much thought, but it is essential. CEO'S REPORT

... a *Private Member's Bill* had been introduced in the legislature to remove trade barriers between provinces.

The benchers last met on May 15, 2025 at which time our new executive officers assumed their offices and the benchers bid farewell to Wayne Onchulenko, to whom we owe a significant debt of gratitude. Wayne began volunteering with the Law Society in 1999 and, since that time, he sat on or has chaired nearly every Law Society committee. For the past nine years, Wayne did so in his capacity as a bencher and for the last several years, Wayne sat on the Law Society Executive, with his final year as Past President. His big shoes will be tough to fill.

Wayne's last official act was to present the Nominating Committee's report, in which the committee recommended the composition and chairs of the committees for the 2025-2026 year. The benchers accepted the report without any changes.

Over the preceding months, the Practice and Ethics Committee and the Indigenous Advisory Committee reviewed a consultation report and proposed changes to the Federation of Law Societies' *Model Code of Professional Conduct* that respond to the Truth and Reconciliation Commission's Call to Action 27. The benchers adopted the recommendations of these committees to provide feedback to the Federation of Law Societies that prioritized the need for ongoing and meaningful education for the legal profession over incorporating rules into the Code of Conduct. The intention of the Federation is to consider all of the feedback received from Canada's law societies and to circulate a second proposal for further consideration and feedback.

CEO REPORT continued...

A monitoring report on the work of the Continuing Professional Development Department was received by the benchers. The benchers have recommended that, over the course of the 2025-2028 Strategic Plan, the Admissions and Education Committee review the current mandatory continuing professional development regime and return to the benchers with any recommendations for change.

Over the weeks preceding the bencher meeting, a Private Member's Bill had been introduced in the legislature to remove trade barriers between provinces. The Bill did not exempt any professions or occupations that had already removed the barriers to mobility within Canada. Accordingly, the Law Society communicated with the Government and the Official Opposition to alert them to the existence of the National Mobility Agreement for Canadian lawyers and to underscore the need to preserve an independent legal profession and, by extension, an independent regulator of the practice of law in Manitoba. On the day of the bencher meeting, the Private Members Bill was defeated and since that time, the Government has introduced legislation that removes trade barriers and which does not apply to the legal profession.

The benchers approved of a proposal to develop an education campaign for the general public regarding the impact of the erosion of the rule of law on the lives of everyday Canadians. We have invited the thirteen other Canadian law societies to join in the campaign to which the responses have been very promising to date.

Richard J. Scott Award Recipient

Karen Busby

Congratulations to Karen Busby who was selected to receive the Richard J. Scott Award for 2025. The award was created in 2013 in honour of Richard J. Scott, former Chief Justice of Manitoba and is awarded annually to an individual who advances the rule of law and contributes to a strong and independent legal profession through advocacy, litigation, teaching, research, writing or mentoring.



Ms Busby is a recent retiree of the University of Manitoba, Faculty of Law following 35 years of excellence in teaching and research in the areas of Violence Against Women, Sexual and Reproductive Rights, Queer Issues, Civil Procedure, Constitutional Law, Administrative Law and Right to Water.

In addition to imparting her vast knowledge to generations of law students, Ms Busby dedicated her career to advocating for human rights and equality in Canada and her works have been cited with approval by Canadian courts at all levels.

Another enduring contribution to the legal community was Ms Busby's work as the editor of the Manitoba Queen's Bench Rules Annotated from 1992 to 2020, the preeminent resource for Manitoba's civil litigators for all civil procedure issues.

The award will be presented to Ms. Busby on Thursday, June 26th at the President's Reception.

Manitoba Law Foundation Grant Funds of \$4.5 million to UM Law to support three new bursaries

Manitobans looking to pursue careers in law at UM will now be able to access a new range of bursaries made possible by grant funds of \$4.5 million from the Manitoba Law Foundation.

Beginning in Autumn 2025, students from diverse backgrounds will have unprecedented access to bursaries that are designed to reduce - and some instances, may eliminate - the financial barriers to accessing legal education.

These bursaries aim to provide students from a variety of backgrounds with critical support to enable them to focus on their studies and their future careers in the legal profession.

"The grant made to the Faculty of Law was intended to support bursaries to reflect the Foundation's deep and ongoing commitment to reconciliation and equity and fostering a legal profession that is representative of the vibrant and diverse communities it serves," said Erin Wilcott, Executive Director of the Manitoba Law Foundation. "They are rooted in our strategic vision of increasing access to justice in the province - particularly in Northern, remote, and rural regions of Manitoba - where legal services remain difficult to access."

Dr. Richard Jochelson, Dean of Law at UM, said the bursaries will go a long way to creating more opportunities for students who may be at a disadvantage due to work obligations and other competing priorities.

"The Faculty of Law is deeply honoured to receive this transformative grant from the Manitoba Law Foundation, supporting the creation and continuation of three vital bursaries" said Jochelson. "These funds help us work towards removing barriers that have historically made it more difficult for individuals from underrepresented communities to pursue legal education and careers. This is such an amazing opportunity for students, the law school and this province."

Over time, these bursaries will help to build a legal profession that is representative of the diversity of Manitoba. All Manitobans, whether they reside in The Pas, Neepawa or Winnipeg, or anywhere else in Manitoba, will have meaningful access to legal services and justice.

Bursary Details

The Manitoba Law Foundation Truth & Reconciliation Bursary

As part of the Foundation's efforts to advance Reconciliation, as well as Access to Justice in a manner that reflects and includes the values and legal orders of First Nations, Inuit, and Métis communities, this bursary is meant to enhance access to legal education and support the membership and participation of individuals from these communities in Manitoba's practicing bar.

The Manitoba Law Foundation Equity & Transformation Bursary

The Foundation believes the practicing bar should reflect the society it serves. This bursary is intended to increase access to legal education, as well as membership and participation in Manitoba's practicing bar, of Black/racialized individuals or other underrepresented and marginalized groups.

The Manitoba Law Foundation Northern, Remote & Rural Access to Justice Bursary

The majority of Manitoba's practising bar resides in Winnipeg. With fewer and fewer new lawyers choosing to practice in Northern, remote, and rural Manitoba, this bursary seeks to enhance access to legal education and support membership and participation in Manitoba's practicing bar for individuals committed to advancing access to justice in Northern, remote, and rural Manitoba.

Up to Full Tuition

Eligible students can apply for a bursary to cover up to full tuition costs in any year of study and could benefit from the bursary for up to three years, as long as they achieve and maintain a satisfactory academic average and can demonstrate continued financial need.

I'M SORRY, I CAN'T SHARE THAT: *Practical Guidance on Client Confidentiality*

As a lawyer, you're already familiar with the importance of client confidentiality — it's one of the cornerstones of our professional obligations. But it's worth revisiting from time to time, especially when you're faced with real-world situations where the lines can feel blurry.




Whether it's a family member asking questions, the Public Guardian and Trustee making a request, or another lawyer looking for details, it's not always easy to know what you can or can't say. This guidance is meant to help you think through those moments and feel more confident in your response.

Common Situations We Hear About:

- A client's adult child asks about their parent's estate plan.
- A friend raises concerns about a Power of Attorney.
- The Public Guardian and Trustee or an Attorney requests information or documents from a client file.
- Law enforcement or another lawyer requests client information.
- An executor asks for details about a deceased client's will or files.







How to Respond:

-  Start with a respectful but clear response — confidentiality doesn't end when a client loses capacity or passes away.
-  Keep it simple and professional — you don't need to explain your reasoning. In most cases it is enough to say you're not able to assist.
-  If you receive a court order or formal demand, take the time to review the **Code of Professional Conduct** and relevant case law. If you're still unsure or something about the request doesn't sit right, that's a good time to check in with us.

Example of a Respectful Response: "I'm sorry, but I'm not able to assist with your request for information about this individual."

A Few Things to Keep in Mind:

-  Your duty of confidentiality and privilege continues after a client's death or incapacity.
-  You should not confirm or deny whether someone is or was a client, unless you have proper consent or legal authority.
-  Not all requests need a call to the Law Society — many can be handled with a careful review of the Code and your own good judgment.
-  But if something feels off, or the request seems too broad or inappropriate, you're absolutely encouraged to reach out for guidance.

EMPLOYERS

Workplaces are expected to provide no assignments to students enrolled in the Accelerated program between May 26, 2025 and August 29, 2025.

Students enrolled in Standard PREP must be given time to not only attend the six workshops in the summer period but to also prepare the required background work expected for the six workshop sessions. Further, workplaces should not be assigning any duties to students which may prevent a student from completing the required activities in the two week Capstone period in February 2026.

Report Your Claims

The current professional liability insurance policy expires July 1, 2025 at 12:01 a.m. That means that you should report any issues on your files that might possibly, at some point in the future, give rise to an insurance claim against you. Insurance Assessment Due

The annual insurance assessment is due on or before July 2, 2025.

You should have received notice of your insurance assessment by email on May 30, 2025. If you did not, go to the Member Portal where it can be found under Payments - Invoices & Receipts.

Exemption Forms Due

Those lawyers who are exempt from insurance must complete and submit their exemption forms before July 2, 2025.

Excess Insurance

If your practice and firm face potential exposure to claims over and above the \$1million per claim limit, you should consider purchasing excess insurance to cover you for that extra risk. Excess insurance applications for the new policy year are available now.
