### Independence

There are two topics we often do not discuss, likely because we take them for granted: first, the independence of judges and lawyers; and secondly, the work we do at the Law Society promoting access to justice in furtherance of our mandate to protect the public. They are related.

### Independence of Judges

During the pandemic we did not swear-in judges in public. Public swearing-in ceremonies are important and this year, the practice has returned. Such ceremonies are not only a time for families of appointees to be proud and for colleagues to honour the new judges' accomplishments, they also are important occasions in the functioning of our legal system. Through the remarks delivered by all three levels of court, legal representatives of the federal and provincial departments of justice, representatives from the Faculty of Law, the Manitoba Bar Association and the Law Society of Manitoba, the public observes the different, independent and essential roles played by the government, the legal profession and the courts in a properly functioning democracy. Essential to this function is the independence not only of the profession but the independence of the judiciary and having government representatives in attendance validates that independence. It has been good to see our new provincial Minister of Justice in regular attendance and most recently, the Premier of Manitoba.

### **Independence of Lawyers**

In British Columbia, the government is contemplating a change to how lawyers will be regulated. While change can bring about efficiencies and improvements, law societies across Canada are carefully following the developments in British Columbia so that we may take steps, if necessary, to prevent the undermining of the independence of lawyers, as self-regulation is essential to the independence of the legal profession.

### PRESIDENT'S REPORT contined...

As noted by Estey, J. in Canada (AG) v. the Law Society of British Columbia [1982] 2 SCR at pp. 335-36:

"The independence of the Bar from the state in all its pervasive manifestations is one of the hallmarks of a free society. Consequently, regulation of these members of the law profession by the state must, so far as by human ingenuity it can be so designed, be free from state interference, in the political sense, with the delivery of services to the individual citizens in the state, particularly in fields of public and criminal law. The public interest in a free society knows no area more sensitive than the independence, impartiality and availability to the general public of the members of the Bar and through those members, legal advice and services generally."

If the legal profession is regulated by non-lawyers, or by government, independence can be undermined and with it the Law Society's ability to protect the public, to maintain the public's trust and the ability to challenge state actions.

### **Access to Justice**

It is a well-known fact that many Manitobans are unable to access information and services to address their legal needs. By facilitating greater access to justice, we help validate why the legal profession should be self-regulated. Here are some of the things we do.

The Law Society has established a regulatory "sandbox" which is a five-year pilot project where non-lawyers may be approved to fill in gaps in legal services. The Society also is in the early stages of developing a trusted intermediaries training program where front line workers of social welfare organizations can gain legal knowledge and information to better support their clients. The Society also is collaborating on the development of a "prelaw" education program at the University College of the North to encourage more law school applications from our northern residents. Through a soon to be expanded definition of "civil society organization", the Law Society is encouraging the delivery of pro bono legal services to clients of social welfare organizations as well as pro bono law clinics.

While achieving better access to justice for Canadians is a monumental task, the Law Society is taking many steps to tackle the issue.

# Meeting with the Minister of Justice Canada

At the request of the Minister of Justice for Canada, I participated in a round table discussion regarding diversity in the Judiciary. The Minister emphasized his commitment to making timely appointments to the bench in Manitoba and noted that currently, there is only one vacancy in the family division. The Minister suggested to the meeting participants that they encourage qualified candidates to apply, indicating that having a large pool of quality candidates allows for a more diverse bench. The Minister also asked participants to encourage the Judicial Advisory Committee to meet frequently to review applications.

### The Bencher Election

A strong, committed and diverse bencher table creates an effective regulator. The 2024 bencher election and appointment process is underway. Please consider running or applying for a seat at the bencher table.

# CEO'S REPORT

The 2024-2025 budget was presented to the benchers, which included an exceptionally high and unprecedented statutory grant from the Manitoba Law Foundation...

The benchers last met on February 8, 2024 where they received a PowerPoint presentation from Liza Worthington, the Chief Executive Officer of CPLED, regarding the progress that has been made in the development of PREP over the past five years. The benchers learned that, under the current model of delivery, students can either complete a nine-month program concurrent with serving their articles or they can complete a three-month condensed program, in advance of articling, where the students will devote all of their time to their studies. Ms Worthington reported that the pass rates of students who have been admitted through the National Committee on Accreditation are consistently lower than students who obtained a Canadian common law degree, particularly those who complete PREP without articles. CPLED has, and continues, to employ methods to assist NCA students, one of which is the very successful Legal Research and Writing Program that is offered as a stand-alone program for students who intend to obtain their Certificate of Qualification through the National Committee on Accreditation.


The benchers received a report on the Part-Time Practising Fees Pilot Program as the Law Society is nearing the conclusion of the two-year pilot project. Due to somewhat limited data that has been generated, the benchers directed that the pilot program be extended for an additional three years and that the Law Society conduct a survey of the profession in the third and final year. The benchers also directed the Law Society to create an "exceptional circumstances" category to be included in the balance of the pilot program, which category will encompass lawyers who, due to a serious health issue, are unable to practise full-time. The parameters of such a category will be decided upon by the benchers at a future meeting.



### **CEO REPORT** contined...

The 2024-2025 budget was presented to the benchers, which included an exceptionally high and unprecedented statutory grant from the Manitoba Law Foundation due to the high rates of interest earned on lawyers' trust accounts in the prior year. Pursuant to s. 90(1) of *The Legal Profession Act*, the statutory grant must be used for educational purposes and for expenses incurred to ensure compliance by lawyers with s. 50(2) of the *Act*. Accordingly, the benchers were apprised of education initiatives that are being pursued for the profession and for the public. A portion of the funds are reserved for future educational endeavours and will factor into the benchers' strategic planning over the course of 2024.

Finally, the benchers struck a special committee to review proposed amendments to the competence section of the national Model Code of Professional Conduct. The committee will return to the benchers with recommendations at a future date.

### Interested in the Work of the Law Society?

The bi-annual Law Society bencher election process will be underway shortly and we encourage all practising members to consider seeking election or appointment to the bencher table. Election day is Wednesday, May 1, 2024.

To be eligible for election or appointment, a member of the Law Society must be a practising lawyer on the 1st Monday in March. Each bencher sits for a two year term, for a maximum of four terms (eight years). Nominations for election are due no later than Monday, April 1, 2024.



# VERIFYING THE IDENTITY OF CLIENTS WHO DO NOT HAVE PHOTO ID

There are some clients who do NOT have valid government issued photo ID such as a driver's license or passport. For example, an elderly client selling the family home or their interest in the family business.

So, how do you verify the ID of someone who can't flash you their government issued photo ID? You can use two pieces of information ('trusted documents') from a reliable source.



This two-piece method requires some advance planning because the two trusted documents must be original – not a photocopy or electronic image like a digital photograph, screen capture or scanned copy. Most clients will not be carrying these documents in their wallets and will need to be instructed to either bring them with them, deliver or snail mail them to you.



# HOW DOES THIS TWO-PIECE INFORMATION/TRUST DOCUMENT METHOD WORK?

### What is a Reliable Source?

The two trusted documents have to come from a reliable source. Federal, provincial or municipal governments, crown corporations, utilities (hydro, gas, telecommunications companies) or financial institutions all qualify as a "reliable source."

# What Information MUST the Two Trusted Documents from the Reliable Source Include?

The trusted documents must include:

- 1 the client's name and address; or
- 2 the client's name and date of birth; or
- information that contains the client's name or confirms they have a deposit account or credit card or other loan with a financial institution.

### **Examples of acceptable trusted documents include:**

- CPP statement
- vehicle registration
- municipal property tax assessment
- CRA issued communication including Notice of Assessment, GST Credit Statement, T4
- utility bills
- foreign travel visa
- record of employment
- government benefits statement
- birth certificate
- permanent resident card
- citizenship certificate
- marriage certificate
- credit card statement
- mortgage statement
- bank statement
- registered investment account statements (e.g. RRSP, TFSA or RRIF)
- insurance documents (e.g. home, auto or life)\*

# FEATURE

### MIX - Don't Match!

You must have two trusted documents from two different reliable sources. This means you can't use the client's October and November TD Visa statements. But you could use the October TD Visa statement and an October President's Choice Financial Master Card statement. And in case you were wondering, the reliable source is the issuer of the information – like the financial institution or Hydro or MPI - not your client.

### You Need to See the Original

The two trusted documents must be original – not a photocopy or electronic image like a digital photograph, screen capture or scanned copy.

If your client gets their information from reliable sources electronically, they can show them to you on their mobile phone or they can log into their account at your office. You can look at the document the reliable source has emailed to them or see the statement on the reliable source's mobile app or secure website, looking over the client's shoulder. Now that you've seen the original, the client can then transmit that trusted document to you or you can take a screen shot or even a cellphone photo of it for your file.



# Using Information from a Reliable Source When You are NOT Meeting with the Client in Person

If you are not meeting with the client in person and the client has the two trusted documents in a hard copy original format, they can snail mail or deliver the original trusted documents to you so you can copy it and mail it back to them.

If the client receives trusted documents from a reliable source electronically, the client can try to email you the document received from the reliable source or to send you a link to the document on the issuer's website or app. You may not be able to open those documents because access to them often requires your client's log-in and password. If you can't open the documents, you may have to arrange an in-person visit by you or through an agent. This might delay the required verification, so plan ahead.

What is Barney's 2 out of 3 rule? When determining if you should take a file or not, you need to make sure you have two of the following:


- 1. You like the money.

If you don't have at least two, the file will linger because you're going to hate working on it.

# **Well-Being**





Confirmation bias – looking for, and finding, the bits of information that support our view. Lawyers do this for a living, don't we? Sure, we also look for the facts and law that are contrary, but really, when we are talking with other lawyers (or anyone), how open are we to listening when they have an opposite view? How do we react?

How emotionally attached are we to our viewpoint? Do we feel personally threatened when someone does not agree with us at work or in our personal life? Do we feel we must criticize or dismiss them, to defend our own view?

Can lawyers sometimes be jerks? (Yes)

According to the *Greater Good Science Centre Magazine*, *Berkeley University*, *California*, **intellectual humility**, "the degree to which people recognize their beliefs might be wrong", is one of ten pillars to support your health and happiness. Research suggests that it can help you learn new things, have better relationships, and be a better leader. People with intellectual humility tend to be more empathetic, compassionate and able to build bridges with ideological opponents in all areas.



### Here are four things to try to cultivate intellectual humility:

Put a little space between your perception and your response

Several studies found that people who journaled about themselves in 3<sup>rd</sup> person became much more humble when reflecting on challenges they had with other people. Observe your reaction before actually reacting.

2 Curiosity

Ask yourself if you have all the information, or if it is possible that the other person has some that you do not. Are you making assumptions? How do our own biases affect our view? Consider how you arrived at this view, and where the information came from. Then, ask these questions about the other person.

**3** Embrace Mistakes

We can benefit more from mistakes when we acknowledge and correct them than by avoiding making mistakes at all costs. Admitting you were wrong takes humility and strength. People will generally respond well when someone can take responsibility for their errors.

4 Awe

We can get caught up in our thoughts and be the centre of our universe. When we turn our attention outwards, we see we are just a small part of the vastness of this immense and complex world. Take an "Awe Walk". Look around. Stars in the sky. Tall green forests. An incredible sunset reflecting on a beautiful building. How many wonderous things can you find?

Be patient as you try to observe how you think about things or respond in a new way.

# **Manitoba Articling Recruitment Guidelines**



These Guidelines are prepared pursuant to Law Society Rule 5-6.1 and concern the recruitment of articling students for positions within the City of Winnipeg. They set out the procedures for the recruitment of articling students in Winnipeg and were developed by representatives of the Manitoba Bar Association (MBA), the Law Society of Manitoba, the Manitoba Law Students Association and the University of Manitoba, Faculty of Law. All Winnipeg firms and organizations engaged in the recruitment of articling students for the 2025–2026 articling year, and all candidates applying to such employers, are expected to adhere to the guidelines and dates set out below. Workplaces outside of Winnipeg who also wish to participate in this recruitment may do so by submitting their firm profile in accordance with the guidelines. By doing so, they will be required to follow the deadlines and procedures set out in these guidelines.

### **Guidelines & Important Dates to Remember for Firms, Organizations and Students**

### **Firm Profiles**

Employers are to provide profiles containing information about the firm's practice, office facilities, the number of articling positions available, the documents required for the application (resume, cover letter, copies of transcripts, etc.), the contact person, address to which applications must be sent, and all other pertinent information to both:

- 1. The Faculty of Law, Career Development Office, via email: <a href="mailto:lisa.griffin@umanitoba.ca">lisa.griffin@umanitoba.ca</a> (phone: 204-474-7932); and
- 2. The Law Society of Manitoba, via email: <a href="mailto:lehnes@lawsociety.mb.ca">lehnes@lawsociety.mb.ca</a> (phone: 204-926-2042)

**no later than 4:00 p.m., Monday, March 18, 2024**. All postings received by this date will be accessible to Robson Hall students through the Faculty of Law Career Development website on Friday, March 22, 2024 by noon and to all others from the Law Society of Manitoba by emailing a request to <a href="mailto:lehnes@lawsociety.mb.ca">lehnes@lawsociety.mb.ca</a>. *Profiles received after Monday, March 18, 2024 will be posted as quickly as possible*.

### **Application Deadline**

The application deadline for students to submit resumes, cover letters and transcripts directly to the employers for 2025-2026 articling positions shall be **12:00 (noon)**, **Tuesday**, **May 14**, **2024**.

### **Interview Call Day**

Interview offers may only be made between the hours of **10:00 a.m. to 4:00 p.m., Friday, May 24, 2024**. No communication regarding interviews may be made prior to this time. Students must respond to an offer of an interview within this same timeframe

### **Recruitment Suspension Period**

Between **4:00 p.m. on Friday, May 24, 2024 and 8:00 a.m. on Monday, June 3, 2024**, neither students nor employers should be involved in any recruitment activity, including but not limited to participating in open houses, firm tours, or similar activities directed at encouraging employment, conducting of interviews, and discussing offers of employment.

Communications and interactions between employers and students related to a summer job placement, and not concerning an articling placement, are not prohibited in this context.

### **Interview Period**

8:00 a.m., Monday, June 3, 2024, to 5:00 p.m., Tuesday, June 11, 2024. Interviews shall not be conducted prior to 8:00 a.m. on Monday, June 3, 2024. Firms and organizations may interview students at a location of their choosing. Both the Law Society of Manitoba and the Faculty of Law may provide space upon request. Please contact <a href="mailto:lehnes@lawsociety.mb.ca">lehnes@lawsociety.mb.ca</a> or <a href="mailto:lisa.griffin@umanitoba.ca">lehnes@lawsociety.mb.ca</a> or <a href="mailto:lisa.griffin@umanitoba.ca">lisa.griffin@umanitoba.ca</a> if you require either.



### **No Contact Period**

There is to be no contact between students and employers between the end of the interview period and the earliest offer date.

### **Eligible Students**

Approved principals or their delegates may make an offer of an articling position only to students who have, at a minimum, completed their second year of law studies. Only students who have, or will have obtained an LL.B., J.D. or CQ from the National Committee of Accreditation on or prior to June 30, 2024 will be eligible to apply for 2025-2026 articling positions

### **Earliest Offer Date**

Approved principals or their delegates may **not** make an offer of an articling position in Winnipeg for the 2024-2025 articling term **before 2:00 p.m. on Wednesday, June 12, 2024**. Offers made on June 12, 2024 must remain open until 10:00 a.m. of the following morning. Offers made on June 12, 2024 can be accepted or rejected by students anytime before 10:00 a.m. on June 13, but must be responded to by that time. Offers made **after** June 13, 2024 must be responded to no later than 10:00 a.m. the following morning.

### **Content of Offers**

At the time the offer is made, employers must provide students with the name and contact information of the person to whom the student should communicate acceptance or rejection of the offer. Employers are also encouraged to include pertinent information with the offer, such as the proposed start date, salary and benefits.

### **Communication of Acceptance/Rejection**

As a courtesy to employers and fellow students, students shall deal with offers received as soon as reasonably possible. Once a student has accepted an offer from one employer, the student must promptly communicate his/her rejection to any other employer that has extended an offer to the student. Failure to promptly communicate rejection of an offer prejudices the offering employer, as well as fellow students to whom subsequent offers may be made.

### **Accepted Offers**

Once an offer has been accepted, neither the employer nor the student may withdraw from the agreement without the permission of the Chief Executive Officer of the Law Society of Manitoba.

# Offer of Articling Positions after June 13, 2024

Employers may contact students directly to fill any unfilled articling positions. Offers made after June 13, 2024 must remain open until 10:00 a.m. the following day, unless accepted or rejected by the student.



### **Communication of Results**

Once an offer has been accepted, the student and the employer **must immediately** advise **both**:
