### What's New

They say time flies when you're having fun. If that's true, then this last year has been the most fun of my life. My presidency has been a whirlwind of travel and networking, strategic planning, governing, and putting out fires (mostly of my own creation). It has been one of the greatest honours of my life to be able to serve the public interest and the profession in this capacity, and I will be forever grateful for all that I have learned, and the friends that I have made through my involvement with the Law Society of Manitoba.

Going into my term, I fully expected wellness to be my main focus. The well-being of the profession has long been a priority of mine, and my goal was to continue to advance lawyer wellness while I was president. While wellness is still a huge priority to me, life had other plans for my time and energy.

The world as we know it has changed. Not just shifted - it's been turned on its head. The things that we learned as "foundational principles" in law school, that we have taken for granted as being untouchable institutions, are under direct attack. The rule of law is suddenly vulnerable, and it's nothing short of terrifying.

As many readers will know, I learned this lesson personally, when a colleague of mine was singled out for sanction because of his association to me, which made him distasteful because of my representation of a particularly ill-reputed client. Thankfully, professional and public backlash was intense and immediate, and the necessity of the independence of the legal profession was ultimately affirmed. This was, however, one small victory in a much larger sea of attacks.

### PRESIDENT'S REPORT contined...

In the U.S., law firms that dared to challenge the Trump administration are under direct attack. Many are making the "Sophie's choice" to settle with the administration in order to stay in business. While facially understandable, the notion that private law firms can be threatened with governmental sanction because they dare to challenge the president or his policies is alarming, and, rather than fighting the constitutionality of this government action, many law firms are setting a dangerous precedent by legitimizing these attacks through the acknowledgment of wrongdoing and making "reparations".

In Canada, the attacks on the rule of law are also evident. The regulation of the legal profession is in the process of being fundamentally changed in B.C, justice funding and the parameters of lawyer regulation are under attack in Alberta, the Ontario Premier openly states his intention to appoint judges who will advance his "tough on crime" agenda, and the federal government is proposing to sanction immigration lawyers across the country if they do not comply with federal regulations that may compromise solicitor/client privilege, to name a few.

The role of lawyers in a democracy has never been so evident, or important. There's a reason why Dick the Butcher wanted to "kill all the lawyers" in Shakespeare's *King Henry VI*. He wanted to overthrow the government, and knew for his coup to prevail, he had to "eradicate society of the defenders of justice who could stop his revolt" (that language is from academic commentary on the play).

So, if there is one legacy that I can leave, one lesson that I can impart, it's that we have to do more than just remain vigilant. We have to challenge the erosion of the rule of law wherever it is threatened. We have to be the front line against authoritarianism. We have to be the "defenders of justice who stop the revolt."

#### **New Executive Officers**

I am very pleased to report that the benchers held their executive officers election at the March 20, 2025 bencher meeting at which time Kyle Dear was elected to be the Law Society's President for the 2025-2026 year and Ken Mandzuik, KC, was elected to the role of Vice-President. They will join Gerri Wiebe, KC (Past President) and Carmen Nedohin, who will begin the second year of her term as Officer-at-Large. I am very much looking forward to working with the new executive officers as we commence the work of the 2025-2028 Strategic Plan.

#### **Networking Events**

The Law Society was pleased to partner with the MBA and the Manitoba Indigenous Law Students Association to host the Building Connections Event for practising lawyers, Indigenous law students and articling students. Both the participation and engagement were fantastic.

Shortly thereafter, the Law Society once again partnered with the MBA to host a networking event for Internationally Trained Lawyers and those seeking to practise their profession in Manitoba. We were vey pleased to have Deborah Wolfe, the Executive Director of the National Committee on Accreditation, attend the event and bring greetings on behalf of the Federation of Law Societies of Canada.

#### **Rule of Law and Trade Barriers**

In response to the tariffs recently imposed on Canada by the United States government, Canadian provinces are at various stages of enacting legislation to remove trade barriers between provinces. Given that Canada's law societies already have removed inter-provincial barriers to practice law through the National Mobility Agreement, we have

been actively working to persuade the government of Manitoba that no change is required for the legal profession, particularly in light of the fact that law societies have removed such barriers in a manner that ensures appropriate regulatory oversight and insurance coverage.

#### **Bencher Business**

At the bencher meeting of March 20<sup>th</sup>, the benchers approved of the 2025-2028 Strategic Plan, in which they have directed the Law Society to focus its energies on five key areas: (1) improving and enhancing the competence of Manitoba lawyers, with some emphasis on supporting internationally trained lawyers, along with solo and small firm practitioners; (2) improving Manitoban's access to justice, with a particular initiative aimed at building a coalition of services across the province; (3) promoting and improving equity, diversity and inclusion for Indigenous and racialized lawyers; (4) building public and stakeholder confidence, with emphasis on the rule of law and the role of an independent regulator, as well as continuing to build relationships with our rural and northern communities; and (5) promoting and supporting a culture of well-being in the legal profession.

The development of an activity plan to achieve the strategic goals is well underway and will be presented to the benchers at their June meeting.

In furtherance of the electronic banking initiative, the benchers approved, in principle, Law Society rule amendments which will enable firms to move funds out of trust electronically, with appropriate systems in place and the requisite approval from the Law Society. The amendments are in translation and will be presented to the benchers in English and French for final approval at a future bencher meeting.

### **PROTECT CLIENT INFORMATION WHEN TAKING YOUR PHONE OR LAPTOP ACROSS BORDERS** *It's Critical to Plan Ahead*

The Government of Canada recently issued a <u>travel advisory for Canadians travelling to the US</u>. Among other things, it reminds Canadians that US border agents are entitled to search travellers' phones, laptops or tablets. They do not have to provide you a reason when requesting a password to open your device.

If you refuse to provide the password, there are consequences. <u>US Customs and Border Protection (CBP)</u> <u>may refuse entry, detain you or seize your device.</u> If your device is seized, agents have the authority to conduct a manual search of content easily accessible on your device. If there is suspicion of illegal activity, searches involving external equipment to analyze and copy your device's content can be conducted.

You phone or laptop could hold a lot of information about your personal life. It is up to you how much of your own personal information you are prepared to reveal at the border This includes social media posts, and emails and texts that are critical of the US. Articles in various news outlets have reported some foreign nationals have been denied entry because of the traveller's perceived anti-American sentiments. You also don't want border agents to see other personal and confidential items that you may have saved to your phone, for example your child's birth certificate, your saved credit card information, or that racy novel you planned to read on vacation. But that is your choice.

But if you have **client information** on your devices, it is your professional obligation to uphold solicitor client privilege. You MUST protect your clients' information.

### How Can You Protect Your Clients' Confidential Information at a Border Search?

- **1.** Limit the amount of digital information you carry across the border.
- **2.** Leave unnecessary devices at home or consider travelling with temporary devices like an old phone, wiped and reactivated, or "burner" phone.
- **3.** Delete unnecessary personal information, including cookies, cache and browsing history and remember to empty your trash!
- **4.** Delete your email app on your phone and instead access email through a browser. This makes accessing email on your phone less convenient for you but tougher for others to access client confidential material.
- **5.** Before crossing the border, put your device in airplane or flight mode so remote files don't get downloaded accidentally. Border agents can't look through your email inboxes or cloud storage if your device is 'offline' in airplane or flight mode.
- **6.** Delete confidential or sensitive data or move it to secure cloud storage to download again once you've crossed the border. Don't forget to delete items you might have saved to your desktop.
- 1. Log out of any apps and/or browsers that give easy access to your cloud-based data, your VPN or 'tunnel' and any other online accounts. By temporarily removing your easy access, you can better protect client data. Remove any user names and passwords or other credentials you may have saved. Encryption, secure passwords and multi-factor authentication, which we urge you to adopt to protect you from cyber criminals, will not stop the border agent from accessing your device initially, but if your device is seized, access to data will be more difficult.
- **8.** Get help from your information technology advisor or IT professional about how to secure your devices and protect privileged information you need to carry across the border.

In 2018, the Federation of Law Societies of Canada published <u>Crossing the Border with Electronic Devices: What</u> <u>Canadian Legal Professionals Should Know</u>. While that report was triggered by a series of cases where lawyers' devices were searched by Canadian customs agents, it is worth rereading.

Ultimately, it is up to you to make decisions about what personal information you are prepared to be seen by border agents, but if you have **client information** on your devices, it is your professional obligation to take appropriate steps to protect solicitor client privilege.



### IS \$1 MILLION ENOUGH PROFESSIONAL LIABILITY INSURANCE FOR YOUR PRACTICE?

#### Your Mandatory \$1 Million Coverage

You, like every insured lawyer in the province of Manitoba, have **mandatory** insurance coverage of \$1 million per claim with an annual aggregate limit of \$2 million. The \$1 million per claim limit means if a disgruntled former client presents a claim against you between July 1, 2024 and July 1, 2025 you would have coverage for up to \$1 million for that claim (defence and damages combined). The annual aggregate means if multiple unhappy clients each make separate claims against you between July 1, 2024 and July 1, 2024 and July 1, 2024 and July 1, 2025, you have a total of \$2 million to cover the damage and defence costs on those claims. Once you hit that \$2 million cap, you are on your own.

#### **CLIA Excess Insurance**

You should consider these limits of insurance when you decide how much is enough coverage for your practice. You can can purchase excess insurance that covers your firm (whether you are in a solo practice or a large firm) for claims that might arise after your \$1 million per claim and \$2 million aggregate limits have been exhausted. Excess coverage is available through the Law Society's own reciprocal, the Canadian Lawyers Insurance Association (CLIA), in amounts from \$1 million to \$35 million. The online applications will be available after May 5, 2025 on the <u>CLIA website</u>. Or contact CLIA directly at <u>service@clia.ca</u> for more information.

### **Claims Made**

Like most excess liability policies, CLIA's excess liability program is "**Claims Made**" meaning that you will need to have insurance in place when a claim is made and not when the work was done. It is **not** transaction-based coverage. You can't buy insurance specific to a particular file or deal. Firms that do not renew their excess insurance will not have coverage for losses reported after the expiry date of the policy. So, if you purchased coverage with a specific transaction in mind, that coverage will need to be renewed as long as the possibility of a claim arising out of that transaction still exists.

Excess insurance is different from mandatory coverage in this respect. On your mandatory coverage, as long as you had insurance at the date of the alleged error, you are covered for that claim even if, when the claim is presented, you are no longer insured, practising or alive. Mandatory coverage stays with you forever. Excess insurance does not.

#### Seamless Coverage

Purchasing your excess liability coverage through CLIA provides you with seamless coverage. Your initial report to Professional Liability Claims Fund staff here in Manitoba is deemed a report to CLIA. So, if a claim that initially looked like it wasn't going anywhere suddenly and unexpectedly takes a bad turn some years later, you will still be covered, because it was considered reported to CLIA at day one.





#### **Coverage in Retirement**

Lawyers contemplating retirement often call us about continuing coverage. If you were insured under the mandatory coverage when you did the work, you continue to have \$1 million mandatory coverage even if you are no longer practising when a claim is made. But, depending on your practice before you retired, you may need more than that \$1 million mandatory limit of coverage to give you comfort in your retirement. CLIA is able to provide retired inactive lawyers with excess insurance at a discounted rate. Check with your accountant, but for most retired lawyers, that premium would also be tax deductible.

### Practice

### Things to Consider When Making Your Decision to Buy Excess Insurance:

#### Does your client require it?

Some clients require proof of excess insurance. Lenders may require insurance at a level that matches a loan advance. Some government agencies or large corporations may require proof of a minimum level of insurance that is higher than the mandatory \$1 million as a condition of the retainer. You can buy excess from CLIA now or at any time throughout the year, but remember, coverage purchased with a single transaction in mind should be renewed as long as the possibility of a claim relating to that transaction still exists.

### Do you or your partners practise in an area of law with a higher risk of many claims or of larger claims?

Some areas of law consistently result in more frequent claims. For instance, real estate files account for the highest number of claims by volume, but these are usually less costly per claim. Missed limitations or dismissals for delay on medical malpractice or personal injury files, or securities or tax law related claims arise less frequently, but damages tend to be more severe. When you are deciding whether to purchase excess insurance and in what amount, consider whether your practice and that of your partners and associates falls into areas of law that are high risk for frequent claims or high risk for severity.

### Do you and members of your firm handle large dollar value files?

You should also assess the potential quantum of damages arising out of potential claims. Valuable estates, farm transactions and family law files where the value of assets is high all have the potential to develop into large claims. Personal injury, including medical malpractice, has potentially high value if limitations are missed or claims are dismissed for delay. If you and your firm seldom deal with matters where more than \$500,000 is at issue, you may not feel such a pressing need. However, large claims continue to arise out of unforeseen areas of law. For instance, ten years ago, we did not expect to see drafting and executing wills as a top five area of law for frequency of claims. We also did not expect ineffective counsel at first instance to be a common ground of appeal in criminal law, with resulting claims.

### Could large defence expenses erode your \$1 million coverage?

You should also remember that it is not only the indemnity or damage payment which might ultimately erode the limits of your insurance. Defence costs eat into your coverage limits. There have been claims in Canada where costs incurred in defending lawyers in complex legal malpractice suits have exceeded \$1 million, with the mandatory limit totally gone before damages are paid. We have had several professional liability files in Manitoba where legal defence costs were more than \$700,000 (preliminary motions, multiple parties, expensive experts and then lengthy trials, appeals and leave applications all add up). The cost of defending these claims dramatically decreases the amount left to satisfy damage awards.

#### Do you have a large tolerance for personal risk?

In the United States, only two states require lawyers to have any professional liability insurance. Lawyers there 'creditor proof' themselves against claims by clients and hope that they don't make any mistakes. Consider whether you are comfortable being personally exposed to a claim that exceeds \$1 million.





#### The Decision is Yours

You are the only one who can assess your firm's exposure to a claim or series of claims that might take you over the mandatory \$1 million limit or the annual \$2 million aggregate limit. Take some time and consider your exposure.

### **SPEAK NOW OR FOREVER HOLD YOUR PEACE**

#### TANA CHRISTIANSON, Director of Insurance

Your current professional liability insurance policy will expire July 1, 2025 at 12.01 a.m. So, if you are aware of an issue which might possibly, at some point in the future, give rise to an insurance claim against you, report it now.

#### Why Report Potential Claims Now?

Your new policy only covers claims if you had no knowledge of the claim or potential claim before July 1, 2025 and could not have reasonably foreseen that a claim might arise. That means if you want coverage and are aware of a problem or have a file keeping you up at night, report before July 1, 2025 when the current policy runs out.

#### What Should You Report?

Report all files that have the potential to turn into a claim where:

- 1) You think you might have made an error or are concerned about a file; or,
- 2) Someone is making allegations (even unmeritorious allegations) against you.

### **PREP SESSIONS** Additional Information for Firms and Students

### **EMPLOYERS**

Workplaces are expected to not provide assignments to students enrolled in the **Accelerated PREP Program** between May 26, 2025 and August 29, 2025.

Students enrolled in the **Regular PREP Program** must be given time to not only attend the six workshops in the summer period, but to also prepare the required background work expected for the six workshop sessions. Further, workplaces should not be assigning any duties to students which may prevent a student from completing the required activities in the two week Capstone period in February 2026.

### PREP TUITION SUBSIDY

Students registered with the Law Society as an articling student member are eligible for the PREP tuition subsidy. The Law Society of Manitoba will pay a subsidy of \$2600 plus applicable taxes to assist with CPLED tuition costs which have been paid in full. The subsidy will be paid to the student, or to the workplace if the workplace has made the payment to CPLED. Payments of the subsidy amounts will be made in instances where the full tuition has been paid to CPLED and upon confirmation from CPLED that tuition has been paid in full. The Law Society will process the subsidy payments at the start of the course for those paying the entire tuition amount at the start and at phase four of the course for those paying the tuition over four installments.

### PILOT FALL ACCELERATED PROGRAM

CPLED is also adding, on a pilot basis, a second Accelerated PREP offering in the fall of 2025. This will be of benefit to any student not able to obtain their JD or CQ by the deadlines set by CPLED to register for the Accelerated or Regular PREP sessions.

### **IN MEMORIAM**

**Margaret Anne MacLeod**, who passed away on December 23, 2024 at the age of 85. Ms MacLeod received her call to the Bar on June 24, 1982. She was a practising member of the Law Society for eight years.

**Robert Allan Simpson**, who passed away on January 25, 2025 at the age of 76. Mr. Simpson received his call to the Bar on June 25, 1974. He practised with D'Arcy & Deacon for five years before joining Fillmore Riley LLP where he continued to practise up to the date of his death.

**Marston Welland Grindey**, who passed away on January 29, 2025 at the age of 80. Mr. Grindey served as a lay bencher and public representative for the Law Society from 2010 to 2022.

**Sheldon Edward Pinx, KC**, who passed away on February 4, 2025 at the age of 77. Mr. Pinx received his call to the Bar on June 26, 1973. He began his career as counsel with Legal Aid Manitoba. In 1976 he joined Wolinsky & Company where he practised for five years. In 1981 he joined the firm known today as Pinx & Company, where he continued to practise up to the date of his death. Mr. Pinx was appointed King's Counsel in 1990.

**Marion Lillian Ironquil Meadmore**, who passed away on February 19, 2025 at the age of 89. A champion for Indigenous self-governance and economic development, Ms Meadmore was cofounder of the first Indian and Métis Friendship Centre in Canada (1959), cofounder of the organizations that are known today as the Assembly of First Nations and the Assembly of Manitoba Chiefs (1963), and cofounder of Kinew Housing (1970). Ms Meadmore received her call to the Bar as the first Indigenous female lawyer in Canada on June 29, 1978. She was a practising member of the Law Society for six years. In 1984 Ms Meadmore was named a Member of the Order of Canada.

**Boris Alexander Hwozdulych**, who passed away on February 21, 2025 at the age of 72. Mr. Hwozdulych received his call to the Bar on June 25, 1976. He practised as counsel for Legal Aid Manitoba for the entirety of his career, retiring in 2019.

**Kenneth Mark Tennenhouse**, who passed away on February 27, 2025 at the age of 66. Mr. Tennenhouse received his call to the Bar on June 23, 1983. He then joined Manitoba Hydro where he practised for 36 years, serving as in-house counsel, Vice-President, General Counsel and Secretary. Mr. Tennenhouse continued to practice as a sole practitioner from 2020 until his retirement in 2024.

**Joseph Jean Marcel Romuald Gregoire**, who passed away on February 28, 2025 at the age of 78. Mr. Gregoire received his call to the Bar on June 25, 1974. He practised for two years as an associate with Wilson & Coppleman in Russell, Manitoba and then as a sole practitioner in Roblin, Manitoba until his retirement in 2016.
