Creating your account and enrolling in the course

1 Go to: https://nvisionthepath.ca/course/view.php?id=174

Already completed The Path through another provider, such as the Canadian Bar Association? Read about your options included at the end of this guide.

2 Scroll down and select Create new account.

If you already have an account for The Path, enter your existing username and password at the top of the page, select Log in, and then skip to step 6. If you forgot your password, you can reset it on the NVision website.

Your username must use only lowercase letters and your password must follow NVision's guidelines.

Note that the username and password you create for The Path are not the same as the ones you use to access the Member Portal.

4 A message displays to indicate that a confirmation email from *noreply@nvisionthepath.ca* was sent to the email address you provided to create your account in the previous step.

6 The **Enrolment options** window opens. Enter the **LSM Enrolment Key*** in the field and then select **Enrol Me**.

*You can find the **enrolment key** in the email sent to you from the Law Society at the time you were invited to enroll in the course, or you can contact path@lawsociety.mb.ca

Do not share the enrolment key. It can only be used by Manitoba lawyers required to take The Path (Law Society of Manitoba).

8 The Welcome - Start Here page opens. Select Click HERE to begin.

Follow the navigation instructions within the course to complete The Path.



Your progress is tracked by the learning management system, so you can complete the course at your own pace (within the completion timeframe set by the Law Society).

Completing the Course

After you have completed all course modules:

1 Select the **Final Step**, **Survey**, **Certificate** link.



- **2** Follow the on-screen instructions to complete the course. This includes:
 - Entering your LSM Member Number and your First and Last name.

This step must be completed in order for the Law Society to confirm that you have completed this education requirement, and for you to receive your course completion certificate.

• Downloading your **certificate of achievement** to verify you completed the course.

NVision will provide the Law Society with monthly course completion reports. You do not have to produce your certificate unless requested by the Law Society.

• Completing the anonymous **Feedback Form**.

Already completed The Path?

If you have already completed The Path through another provider, such as the Canadian Bar Association, you are eligible to take the Manitoba-specific lessons only.

We do, however, encourage you to take the full course again.

Please note that you will be required to certify your eligibility to take the Manitoba-specific lessons upon access.
