## ORIGINAL

THE CHAIRPERSON: So we are resuming the hearing now, and I will present the panel's findings.

We have considered the joint submission as set out in the Agreed Statement of Facts filed as Exhibit 3 herein. The panel accepts the plea of guilty to the single charge in the April 25, 2016 citation, and charges 1 and 2 in the July 5, 2016 citation.

The panel finds that there was professional misconduct demonstrated by Ms. Gembey. The panel wishes to once again emphasize the importance of the members' cooperation in the investigation of matters, and the critical nature of members' compliance with governance obligations of The Law Society of Manitoba.

The confidence of the public in lawyers is undermined, and the ability of The Law Society to protect the public interest is compromised when a member fails to cooperate. The member herself acknowledged to the panel the importance of the Society's governance structure, and the need for compliance.

The panel is satisfied that the joint submission both meets the proper application of the sentencing factors enunciated by former panels in like circumstances, and the particular circumstances facing this member as to disposition.

As a result, the panel finds that there is no
