- (c) the dissolution or winding up of the partnership,

and will do so before or immediately after the change takes place.

11. The partnership will provide the Chief Executive Officer with proof of the renewal of its registration as an extra-provincial LLP with the Companies Office within 15 days from the date of renewal.
