- (c) I will not provide advice on matters of Manitoba and Canadian law, represent clients in any court, prepare or participate in preparing any document or instrument which is or may be governed by the laws of Manitoba or Canada, or hold myself out as qualified to act as a member of the Law Society of Manitoba;
- (d) I will not accept, hold, transfer or in any other manner deal with trust funds or client property;
- (e) I will notify the Chief Executive Officer promptly if I cease to be entitled to practise law in my home jurisdiction and fail to satisfy any applicable legal education requirement of my home jurisdiction;
