This is a unique opportunity to serve the public, promote community safety, and uphold the administration of justice in Saskatchewan.

As a Crown Prosecutor, you will help deliver justice through fair, ethical and effective prosecutions.

Public Prosecutions prosecutes those charged under the *Criminal Code*, *Youth Criminal Justice Act* and some provincial and federal statutes. Public Prosecutions assists in promoting safe communities through the just conclusion of criminal charges.

The work offers an intellectual challenge and an opportunity to make a difference in your community. Your work as a Crown Prosecutor will be important to the community you'll call home and those throughout the region.

Under the direction of Public Prosecutions' Head Office and a Regional Crown Prosecutor, you will be responsible for a multitude of duties and decisions. Primary duties are the carriage of criminal, quasi-criminal, and regulatory prosecutions in the Provincial Court for Saskatchewan and the Court of King's Bench for Saskatchewan. This will include docket court work, trial work, and summary conviction appeals. Other duties include meeting and communicating with victims and witnesses, giving legal opinions, reviewing police reports, and advising police as appropriate. The successful candidate will be expected to participate in legal education in the areas of criminal law, ethics, and the criminal justice system.

The hours of work can vary and include working evenings and weekends when duties require. Travel by road is required and possibly by air, with work possibly requiring overnight stays in other communities.

The competitive salary will be commensurate with experience and qualifications. The successful candidate will be entitled to at least three weeks' annual vacation, twelve scheduled days off, and statutory holidays. A full benefit package is available after six months of service.

Technical Knowledge and Skills:

You must:

- Be a qualified lawyer.
- Be eligible for membership and maintain membership in good standing with the Law Society of Saskatchewan.
- Hold a valid Class 5 driver's licence and be able to travel regularly to court locations by vehicle and, occasionally, by air.
- Demonstrate strong advocacy, judgment, and decision-making skills.
- Be able to manage complex and sensitive legal matters in a fast-paced
